



**5A Convention of Cooperation
Between
Al Azhar University, Cairo, Egypt
And
Institute of Pesantren KH Abd Chalim,
Mojokerto, Indonesia**



- Al Azhar University in Cairo, Egypt (herein referred as first party)
- Institut of Pesantren KH Abdul Chalim in Mojokerto, Indonesia (herein referred as second party)

Considering that both parties are mutual interested in promoting and developing a friendly relationship and in establishing an international cooperation in the academic and scientific fields, both parties have agreed upon the following;

Article one: This convention aims at promoting academic and scientific cooperation and research as well as mutual understanding between the two parties

Article two: Both parties have mutually agreed on promoting academic cooperation in the following areas that are common to both of them, within their perspective abilities and capacity, such as:

1. The exchange of academic staff;
 - The exchange of lecturer and academic staff between both parties
 - The promotion of academic cooperation in the program of continuing education, serving society, and training program for development
2. The student exchange program
 - The exchange of undergraduate students
 - The exchange of graduate students
 - The short course program for students
3. Research cooperation
 - The promotion of cooperation in research projects
 - The exchange of research staff
 - The promotion of cooperation in research topic
 - The cooperation of research results as publication manuscript to international indexed journal
4. Organizing of academic, scientific, and technical symposiums, conference, international seminars, training course, and other collaborative activities agreed upon by both parties

5. The exchange of electronic reference materials
6. The cooperation in developing academic programs, curricula and courses
7. The collaboration in holding cultural and athletic weeks in addition to other types of activities in both institutions
8. The encouragement to benefit from the scientific and academic experience between institutions
9. The sponsoring of talented, distinguished, and excellent students in both parties in various level
10. The collaboration in teaching Arabic and Indonesian as foreign languages.
11. The joint collaboration and benefit from the technical field and the electronic portal in both parties.

Article three: It is negotiated and agreed upon that any execution or inclusion of an activity based on this agreement is done separately between faculties, schools, and institutes that execute these activities

Article four: This convention may be subject to amendments by written correspondence signed by a representatives of each of the parties, and this agreement may be renewed after both parties have reviewed it and agreed on any amendments made to its clauses

Article five: This agreement has been signed and executed in Arabic and English languages in two (2) original copies, one for each party.
